

VYEPTI CONNECT™ Offerings*



Benefits investigation support includes gathering medical coverage requirements, assignment of benefits, and, if applicable, site-of-care requirements of the payer. For assignment of benefits, if Lundbeck's approved specialty pharmacies are not in the payer's network, VYEPTI CONNECT can inquire about the letter of agreement process.



Prior authorization (PA)/medical exception support provides information on determining coverage and completing a PA form for patient access to VYEPTI™ (eptinezumab-jjmr). Once a PA is submitted, VYEPTI CONNECT will monitor and communicate the status of the PA to the office.



Appeals support offers information on health plan coverage denials and responses. In addition, VYEPTI CONNECT will monitor and communicate the status of appeals to the office.



Alternate site of care search is conducted by VYEPTI CONNECT for patients with providers who are not able or do not wish to administer VYEPTI in their office. VYEPTI CONNECT can also check the patient's insurance to find site-of-care locations that are in his or her network.



Financial assistance is available for eligible commercially insured patients[†] through the VYEPTI Copay Assistance Program. Patients may pay as little as \$5 per infusion every 3 months for VYEPTI. A maximum annual benefit limit of \$4000 and other restrictions may apply. Patients can check eligibility requirements and enroll in the program at www.VYEPTI.com or by calling 833-4-VYEPTI.
